The Customer hereby contacts with Allstate Private Car and Limo Inc. upon the following terms and conditions:

1. The Customer, if he/she is an individual, states and affirms that he/she is employed by (name, address and telephone)_____.
2. The Customer shall pay all charges, costs and expenses for all services as listed in the Allstate Private Car and Limo Inc. Rate Book ("Book").
3. The Customer shall pay a \$4.00 charge per voucher processing fee.
4. Allstate Private Car and Limo Inc. Has the right to update our Rate Book and any of the services, charges, costs fees and expenses at any time without prior notice.
5. Payment is to be received by Allstate Private Car and Limo Inc. Within THIRTY days if the date of the bill. Any payment not received within that time shall have interest charges added in the amount of the lesser of (a) two percent per month or (b) the highest amount permitted by law.
6. If Customer is late in paying any bill and Allstate Private Car and Limo Inc. Retains legal counsel regarding any payment due by the Customer or the enforcement of any provision under this Agreement, the Customer hereby agrees to pay all legal fees (in the amount of the grater of 1/3 of the amount due or Allstate Private Car and Limo Inc.'s attorney's current hourly rate), costs, expenses and disbursements. This includes all actions taken prior to, during and subsequent to the initiation of legal proceeding. This also includes any case when legal counsel is retained but litigation is not initiated.
7. Both parties hereto agree that service upon them of any papers or notices for litigation or any other purposes (except bills and Books maybe sent by Allstate Private Car and Limo Inc.. by U.S. Postal Service mail or by any other means chosen by Allstate Private Car and Limo Inc..) by facsimile or certified mail return receipt requested shall be deemed to be the same as if that person had been personally served in the City of New York on the date of the mailing.
8. The Customer agrees and acknowledges that neither Allstate Private Car and Limo Inc. Neither the franchisee nor the driver shall be liable in any way for any packages, parcels, suitcases, briefcase or any other thing or item given to the driver or placed in the driver's car.
9. The Customer agrees and acknowledges that all vehicles supplied by Allstate Private Car and Limo Inc. Are owned and operated by independent franchisees who are solely responsible for all loses and damages and agrees not to name Allstate Private Car and Limo Inc.. in any proceedings.
10. The Customer shall pay a mandatory 2% NYC surcharge per trip.
